This contract is between _____, hereafter referred to as FARM, and further described as owner of the above mentioned stallion, and _____, owner of the above mentioned mare, and hereafter referred to as CLIENT.

It is hereby understood and agreed that the CLIENT wishes this mare to be bred to this stallion. To bring this about, the CLIENT agrees to the following:

1. To pay a breeding fee of \$_____ includes semen for 1 shipment and a live foal guarantee (see below). A non-refundable booking fee of \$_____ (included in breeding fee) to be paid in advance to reserve the breeding.
2. To pay all shipping fees for receiving and returning Equitainer to FARM. A credit card or Federal Express account number is required.
3. To pay a \$_____ deposit to guarantee the return of the Equitainer and all its components in good condition. If the Equitainer or any of the components are damaged or missing, the cost of replacement will be deducted from the deposit. Equitainer must be returned to FARM within 5 days or deposit will be forfeited.
4. To pay additional lab fees of \$_____ for each subsequent collection/shipment of semen. Fees for additional collection/shipment to be paid in advance of shipment.
5. To have a veterinarian perform an ultrasound on the mare at 16-18 days post breeding to determine pregnancy. Notify FARM immediately of status. Should the mare be found open Client to notify FARM to make arrangements for subsequent shipments.
6. To have mare checked again at 32-35 days and 55-60 days to reconfirm pregnancy. Notify FARM of status.
7. CLIENT will not hold FARM liable for any losses suffered due to any unsuccessful attempts at conception. Further, CLIENT shall assume all responsibility for the condition of the mare and shall bear all risks of loss or damages associated with the breeding of this mare and this Breeding agreement.

Live Foal Guarantee: Should the mare abort or the foal fail to stand and nurse, it is the CLIENTS responsibility to inform FARM in writing, certified by a veterinarian within 10 days of the event. In either case, FARM agrees to re-breed the mare as soon as she is fit. No additional breeding fees will be incurred for a re-breed, however lab fees and transportation fees still apply. The CLIENT agrees to keep the contracted mare in good physical condition throughout her pregnancy, vaccinate for Rhinopneumonitis at 5, 7 and 9 months, and de-worm regularly. A veterinarian using an ultra-sound scan at 16-18 days post breeding must examine the mare. If the mare is in foal, CLIENT must schedule a second ultra-sound scan for 32-35 days post breeding, and have the mare palpated between 55-60 days post breeding. It is required that the CLIENTS veterinarian notify FARM by telephone of mare's pregnancy status at each of these ultra sound scans. If the mare is not in foal, CLIENT must contact FARM immediately so we know your mare will be needing semen. Failure to follow the above mentioned

procedures and health care practices would result in the forfeiture of all re-breeding privileges and breeding fees.

FARM agrees as follows:

1. To collect stallion in an approved manor, and make all efforts to provide CLIENT with the best possible semen.
2. To guarantee a return breeding the following season (provided the stallion is able to service mare) either for said mare or an approved substitute should a live foal (defined as one that stands and nurses without assistance) not result from this mating.

Let it be further understood, the spirit of this contract is to get this mare in foal to this stallion. By affixing their signatures below, the parties to this agreement promise their wholehearted cooperation to this end. If payment plans are to apply to this contract, they will be so stated on this contract and signed by all parties to the contract as attachment A.
